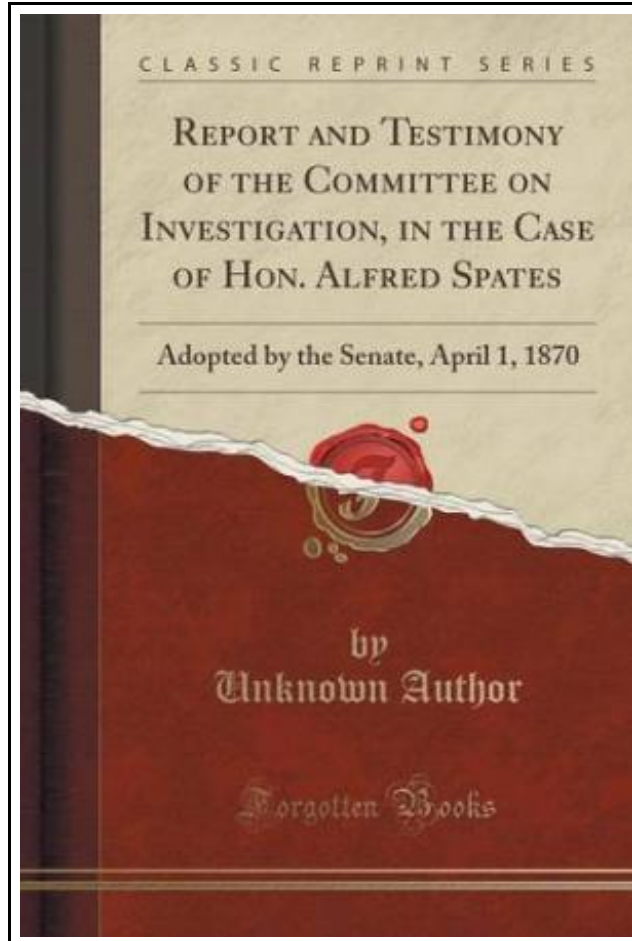

Alfred Spates: Adopted by the Senate, April 1, 1870 The Committee on Accounts, who were directed by a resolution of the Board to examine and report upon the accounts of Alfred Spates, Esq., the late President of the Chesapeake and Ohio Canal Company, beg leave to report: That they have found the task imposed upon them much more laborious and important than they expected, and, although they have bestowed much time upon it, the meeting of the Board find them unprepared to make a full and final report. The results of their investigations, as far as they have been prosecuted, are however so serious that they do not feel themselves at liberty to postpone communicating them to the Board at its present session. Soon after the Committee commenced their labors, they found that it would be necessary to hold a session in the city of Cumberland, and they considered it just to Mr. Spates that he should have an opportunity to be present at their meetings. They accordingly notified him in writing of the time and place of meeting, and afterwards of the particular points to which they then intended to direct their inquiries. He declined to meet them, for reasons which the Board will have full opportunity to appreciate, from his letter, which the Committee communicate with this report. Left to their own guidance, without the advantage of Mr. Spates explanations, the Committee proceeded with their investigation, and now submit the conclusions to which they arrived and the evidence upon which they are founded.
